- **Traumatic Brain Injury MRI:** Simon Med offers one of the most comprehensive traumatic brain injury MRI protocols. Our protocol includes a full brain MRI, DTI, SWI, Neuroquant analysis. These images are read by a board certified neuroradiologist experienced in personal injury litigation.
- **Craniocervical Junction and Alar Ligament studies:** Simon Med is one of the only imaging facilities offering an additional alar ligament / craniocervical junction analysis on our cervical MRI's. This is an in depth look at the ligamentous structure between the base of the skull (aka: occiput), C1 (atlas), C2 (Axis). This is an emerging area of interest in personal injury cases as up to 1/3 of whiplash cases involve damage to this area of the spine. A 3T MRI unit is required to do this study due to the size and detail of the structures analyzed.
